The purpose of a public meeting of the Board of Directors ("Board") is to conduct the affairs of Aveson in public. We are pleased that you are in attendance and hope that you will visit these meetings often. Your participation assures us of continuing community interest in our schools. To assist you in the ease of speaking/participating in our meetings, the following guidelines are provided and are included in Board Policy.

- 1. Agendas are available to all audience members at the door/start to the meeting. Note that the order of business on this agenda may be changed without prior notice. - 2. "Request to Speak" forms are available to all audience members who wish to speak on any agenda items or under the general category of "Oral Communications."
- 3. "Oral Communications" is set aside for members of the audience to raise issues that are not specifically on the agenda. However, due to public meeting laws, the Board can only listen to your issue, not respond or take action. These presentations are limited to three (3) minutes and total time allotted to non-agenda items will not exceed fifteen (15) minutes. The Board may give direction to staff to respond to your concern or you may be offered the option of returning with a citizen-requested item.
- 4. You may specify that you wish to speak on an agenda item by "raising your hand" in the Zoom chat box or speaking up and you will be given an opportunity to speak for up to five (5) minutes when the Board discusses that item.
- 5. When addressing the Board, speakers are requested to state their name and adhere to the time limits set forth.
- 6. Citizens may request that a topic related to school business be placed on a future agenda in accordance with the guidelines in Board Policy. Once such an item is properly agendized and publicly noticed, the Board can respond, interact, and act upon the item.

Dear Aveson Board of Directors.

I visited 14 schools before deciding on Aveson for Saraya, who will be starting the second grade in the fall. I believe in what the school aims to offer. When I heard Kate Bean speak at the information/recruitment session, I knew she believed deeply in personalizing learning in ways that truly and authentically brought students into the learning process. When I visited classrooms, I also saw a school that was intentional about challenging practices that weren't sound and were/are counter to authentic student inquiry and learning. That gave me hope. I believe the guiding principles, though imperfect, can serve as a way forward and provide moral guidance as we seek to navigate our current challenges.

By way of background, I currently hold the position of Regional Director for Big Picture Learning for the West region. That means I work with schools and districts across the Southwest and Pacific Northwest to center equity into their practices, beliefs, and behaviors.

I've led the largest expansion of Big Picture Learning schools in California. Virtually all were transformation efforts, that is, existing schools that changed their practices and systems over a few years.

In addition to this systemic work, I've been a principal twice: as the founding principal of a <u>Big Picture Learning</u> school in NYC and the fourth principal (in three years) of <u>New Village Girls Academy</u>, a

small charter school in Los Angeles where I led it through transformation.

I also work with several communities of practice/justice that are comprised of school/county/district leaders who are in the process of shifting their systems/behaviors/mindsets to actualize the potential of their students, families, and communities. One such effort is the <a href="Deeper Learning Equity Fellows">Deeper Learning Equity Fellows</a>, which I co-lead, design, and facilitate, and is a cohort-based fellowship focused on educational equity and action.

Recently, I've been doing work with <u>Educating All Learners Alliance</u>, an effort to support students with special needs during COVID-19. As part of that work, I'm on an action team that's focused on student agency.

With this, I humbly, but with focus, toss my hat in the ring.
